The Family of Christ Fish Fry will be held at their church on Friday, March 24th from 4-7 p.m. This will be a drive through only event again this year with a portion of the proceeds going to their Southern Boone Scholarship Fund. The cost will be \$15/plate, which will include fried fish, curly fries, baked beans, cole slaw, and dessert. Cash or check only.

The Board met on Thursday, Mar. 9th. They approved \$500 to send a local boy to Boy State. They also voted to provide the Leadership Breakfast for the Chamber of Commerce on April 20th and to split the cost to get the fence row cleaned out with the Saddle Club, at a cost of \$500. They voted against allowing a local business to use our parking for shuttle services, since it would have been on the same day as the Leadership Breakfast in the morning and soccer practice later in the day.

Ernie Wren spoke at the Board meeting requesting to hold a NOW (New Optimists Wanted) meeting on April 8th at our breakfast meeting and reminded members that the 3rd Quarter District meeting is scheduled for May 5-6 in St. Louis. The Board voted to approve up to \$100 for publicity for the NOW meeting.

Madeline Bloss, Ginny Lewis, and Charlie Lewis presented a report about the Little League Basketball program that just wrapped up, followed by Bern Bonderer reporting about the Little League Baseball/Softball program that is just beginning.

This morning we enjoyed a phenomenal breakfast provided by Dorise Slinker, Jennifer Lawson, and Carole Iles of three types of pancakes, as well as the fixings for breakfast burritos. Sue Rogers came as the guest of Lisa Finn and Reece Slinker came to help his dad with breakfast.

Our speaker this morning was Boone County Presiding Commissioner, Kip Kendrick. He started off by speaking about Proposition 1, which will be on the ballot April 4th asking for a 3% tax on the sale of recreational marijuana for the county. The money raised would be used to defray the cost of expungements that were part of the constitutional amendment passed in November. There are deadlines that must be met by June 8th and Dec. 8th, which will require overtime and extra staff.

Kip also spoke about the ARPA (American Rescue Plan Act) funds that will be disbursed within the county. He talked about the fact that one of his first responsibilities after he took office was to set a process for disbursal of funds shared from the Federal government in March of 2021. All funds need to be distributed by 2024 and spent by 2026. Currently applications are being accepted, which will be reviewed for the next several months, with initial decisions of up to \$15 million dollars awarded in June. There will be a second round of application in the fall, with decisions awarded in December.
